SUBJECT: UPDATING THE LIST OF REGULATED UTILITIES

The Commission's procedural Rule 18.02 (Annual Regulatory Fees) authorizes the administrative removal of utilities and railroads from the list of utilities subject to the annual regulatory fee. A utility or railroad may be removed from the list if they: (1) fail to pay their special regulatory fees; (2) are no longer conducting business in Idaho; and (3) fail to maintain a designated agent for service with Commission Secretary, IDAPA 31.01.01.018.02.

The Fiscal and Telecom staff reviewed the current list of utilities and railroads subject to the annual regulatory fee and identified seven (7) telephone companies that meet the criteria above.

Staff determined the attached list of telecommunication carriers meet the three conditions to be administratively removed from the list of utilities subject to the annual regulatory fee. The carriers are identified by company name, the Secretary of State Certificate number (if one exists), the status of the certificate, and in some cases the Order to cancel their Certificate of Public Convenience
