Pursuant to the Idaho Public Utilities Commission's Rule of Procedure 68, Orem Family Wind, LLC hereby files this Notice of Withdrawal of its Complaint filed in this case on December 13, 2010. The Complaint sought a Commission order requiring Avista to enter into a power purchase agreement with Orem Family Wind, LLC, and challenged aspects of the draft agreement tendered by Avista Corporation. Since the date of the filing of the Complaint, Orem Family Wind, LLC has determined it will pursue other alternatives for its qualifying facility, rather than litigate the Complaint against Avista Corporation in this case. Therefore, Orem Family Wind, LLC hereby withdraws its Complaint, and submits that the Commission may close this case.
