YOU ARE FURTHER NOTIFIED that Avista asserts that the proposed procedures generally (1) detail the information QF developers are to provide to the Company; (2) provide timelines for both QF developers and Avista to following the process for negotiating and entering into a power purchase agreement; and (3) provide a dispute resolution process in the event the parties are unable to agree on one or more terms of a power purchase agreement.
