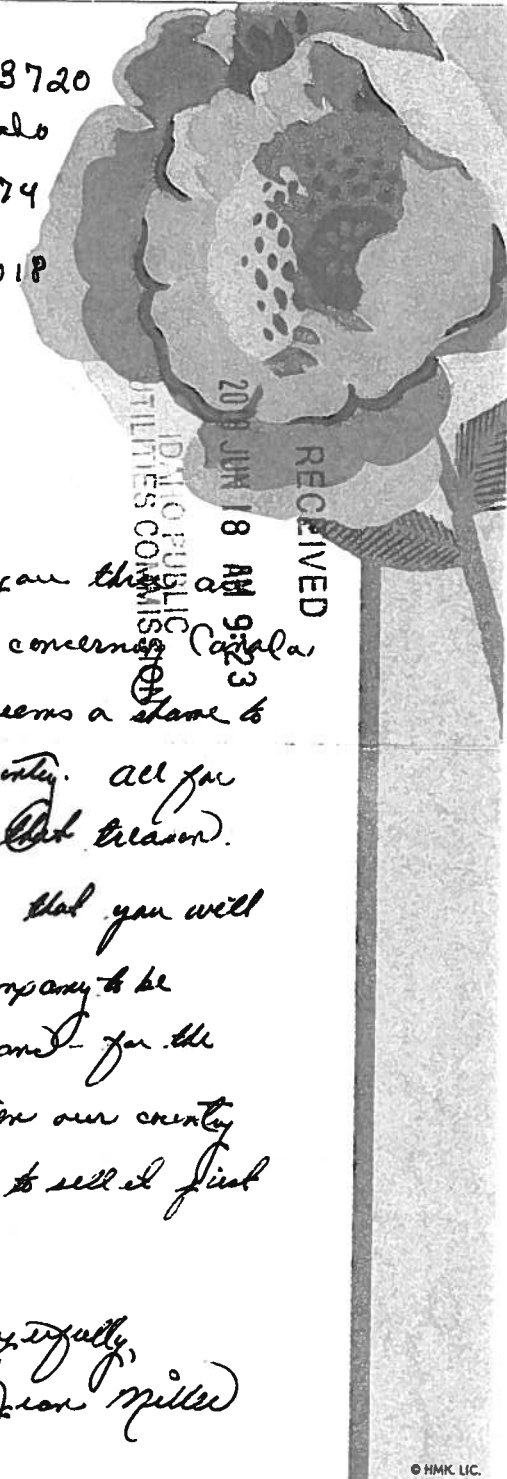
Dear Mr. Anderson,


I strongly object to a foreign entity controlling an American Utility company. Common sense dictates local control! American laws should control Avista....
