On November 16, 2018, Avista Corporation ("Avista" or "Company") filed an Application requesting the Commission determine the Company prudently incurred \$22,719,204 in energy efficiency expenses from January 1, 2016 through December 31, 2017. On December 14, 2018, the Commission issued a Notice of Application and set an intervention deadline. Order No. 34210. Commission Staff has since worked closely with the Company to understand its data and processes. Staff believes that the data, processes, and issues in this case are now sufficiently clear to recommend written comment deadlines.
