NOTICE IF HEREBY GIVEN THAT:

1. The Appellant, Windland, Inc., appeals to the Idaho Supreme Court from the
Idaho Public Utilities Commission's Order No. 31092.

2. Appellant has a right to appeal to the Idaho Supreme Court, and the order
described in paragraph 1 above is an appealable order pursuant to I.A.R. 11(e).

3. Appellant presently intends to assert the following issues on appeal, although Appellant reserves the right to assert other issues on appeal:
 - a) Whether the Idaho Public Utilities Commission violated I.C. § 61-307 when it approved a change in the published avoided cost rates available under the Public Utility Regulatory Policies Act of 1978 in its Order No. 31025.
 - b) Whether the Idaho Public Utilities Commission violated the Procedural Due Process clause of Article 1, Section 13, of the Idaho Constitution when it approved a change in the published avoided cost rates available under the Public Utility Regulatory Policies Act of 1978 in its Order No. 31025.
 - c) Whether the Idaho Public Utilities Commission violated the Procedural Due Process Clause of the Fourteenth Amendment to the United States Constitution when it approved a change in the published avoided cost rates available under the Public Utility Regulatory Policies Act of 1978 in its Order No. 31025.
4. No order has been entered sealing any portion of the record.
5. Appellant is aware of no proceedings in this matter where a reporter was present, and therefore Appellant does not request preparation of the reporter's transcript.
6. Appellant requests preparation of a standard agency record on appeal pursuant to I.A.R. 28.
7. I certify:
 - a) That there is no transcript fee and no reporter on whom to serve this notice because Appellant is aware of no transcript available from this matter.


