On June 8, 2007, Idaho Power filed an Application seeking authority to increase its rates an average of 10.35%. If approved the Company's revenues would increase by \$63.9 million. The increase in base rates would vary by class of customer and actual usage.

On June 25, 2007, the Commission issued a Notice of Application and Intervention Deadline. Order No. 30346. The following parties have been permitted to intervene in this proceeding: the Industrial Customers of Idaho Power; the Idaho Irrigation Pumpers Association, Inc.; the Kroger Company; Micron Technology Inc.; and the United States Department of Energy.


