2. This Intervenor, the Industrial Customers of Idaho Power, ("ICIP") is an unincorporated association of Schedule 19 customers of Idaho Power. All ICIP members receive electric utility services from Idaho Power Company. ICIP claims a direct and substantial interest in this proceeding in that the outcome will affect the Company's power purchase costs which is likely to affect this intervenor's rates for service from Idaho Power Company.

This Intervenor, in its capacity as a representative of industrial customers intends to participate herein as a party, and if necessary, to introduce evidence, submit comments, and fully participate in any hearing that may occur including the calling and cross examination of witnesses. 
