

NOTICE OF WITHDRAWAL OF
COMPLAINT

Pursuant to the Idaho Public Utilities Commission's Rule of Procedure 68, Echo Wind LLC hereby files this Notice of Withdrawal of its Complaint filed in this case on November 8, 2010. The Complaint sought a Commission order requiring Idaho Power Company to enter into a power purchase agreement with Echo Wind LLC's qualifying facility. The Complaint was stayed shortly after it was filed to allow the parties to resolve the dispute. Echo Wind LLC will not continue discussions with Idaho Power Company or attempt to litigate the Complaint further. Therefore, Echo Wind LLC hereby withdraws its Complaint, and submits that the Commission may close this case.
