On October 10, 2013, Idaho Power Company ("Idaho Power") filed its Petition for Clarification and/or Reconsideration of Order No. 32893 ("Petition") in the above matter. In that Petition, Idaho Power incorrectly stated the maximum possible allowance amount as \$490,138.

If the calculation is based upon a per MW basis *added by* the customer, then using \$65,734 per MW times the 7 MW of projected load added, the resulting maximum possible allowance would be \$4**9**0,138.

Idaho Power Petition at 4.

Therefore, Idaho Power hereby files this Errata to correct the maximum possible allowance amount and reflect the total as \$460,138.

If the calculation is based upon a per MW basis *added by* the customer, then using \$65,734 per MW times the 7 MW of projected load added, the resulting maximum possible allowance would be \$460,138.
