On May 6, 2016, Idaho Power Company ("Idaho Power") terminated the Public Utility Regulatory Policies Act of 1978 ("PURPA") Energy Sales Agreement ("ESA") with Pocatello Solar 1, LLC, a PURPA qualifying facility. The ESA was approved by the Idaho Public Utilities Commission ("Commission") by Order No. 33207, issued on January 8, 2015, with an Errata issued on January 9, 2015.

The ESA had a Scheduled Operation Date of December 31, 2016. The ESA was terminated at the request of Pocatello Solar 1, LLC. A copy of the Notice of Termination letter is attached hereto.


