Idaho Power Company ("Idaho Power" or "Company") hereby respectfully submits the following Initial Comments to the Idaho Public Utilities Commission ("Commission") in the above-referenced matter:

1. The Comments of the Commission Staff ("Staff") from Case No. IPC-E-14-19 (Grand View Solar) and Case No. IPC-E-14-20 (Boise City Solar) recommended that the rates contained in the Energy Sales Agreement ("ESA") between Idaho Power and each solar qualifying facility ("QF") be revised to account for energy cost computation issues identified by Staff. Staff recommended two modifications, related to assumptions about the fuel forecast and assumptions about displaceable

resources, to the computation of avoided cost rates utilized by the approved Incremental Cost Integrated Resource Plan Methodology. Idaho Power incorporated Staff's recommended adjustments into the model, and submitted replacement pricing for each ESA. Each QF agreed to replace the pricing in its respective ESA with the replacement pricing that incorporated the revisions recommended by Staff. The Commission then subsequently approved each modified ESA containing the replacement pricing. Order No. 33179 (Grand View Solar); Order No. 33180 (Boise City Solar).

2. Orchard Ranch Solar, LLC, has requested that Idaho Power re-run the pricing contained in its ESA to incorporate Staff's recommended adjustments from the Grand View Solar and Boise City Solar cases. Idaho Power has revised the rates in Orchard Ranch Solar, LLC's ESA to incorporate Staff's recommended adjustments. Idaho Power has generated a Replacement Appendix E to the ESA which contains the revised prices. The Replacement Appendix E is submitted herewith as Attachment 1 in both clean and redlined format. Additionally, included as Attachment 2, in both clean and redlined format, is a replacement page of the ESA that contains a correction to reflect the proper county location of the project.

3. For comparison purposes, the 20-year levelized rate for the ESA as originally submitted is \$62.67/megawatt-hour ("MWh") and the rate from the Replacement Appendix E is \$62.21/MWh. The estimated 20-year contractual obligation based upon the originally submitted prices is \$63,565,295 and the estimated 20-year contractual obligation with the revised prices is \$63,325,585. The levelized integration charge contained in the ESA is the same in both instances at \$5.05/MWh.

4. Idaho Power is not currently aware of whether Orchard Ranch Solar, LLC, agrees to adopt the Replacement Appendix E which incorporates Staff's recommended changes to the pricing model.
