YOU ARE HEREBY NOTIFIED that on December 5, 2006, PacifiCorp dba Rocky Mountain Power filed an Application requesting approval of an Irrigation Load Control Dispatch Pilot Program. Rocky Mountain currently has an Irrigation Load Control Program that rewards customers who allow the Company to interrupt service at designated irrigation pump sites. Rocky Mountain proposes to make changes to the program after convening workshops with members of the Idaho Irrigation Pumpers Association. Rocky Mountain proposes to implement the program on a limited basis during the 2007 irrigation season, making it available on a first-come, first-serve basis up to a total participation of 45 MW. At the conclusion of the 2007 season, the Company plans to evaluate the pilot program and again seek input from participants and Commission Staff.

YOU ARE FURTHER NOTIFIED that the proposed changes would allow the Company to remotely dispatch interruptions by way of a central network server maintained in Boise, Idaho, and interruptions would be at the Company's discretion. Total curtailment per participating customer will be limited to 65 hours during the irrigation season, with dispatch events occurring between the hours of 2:00 p.m. to 8:00 p.m., Monday through Friday. Participants will also have the ability to opt-out of individual dispatch events, up to a limit of five occurrences during the irrigation season. If a participant opts-out of a dispatch event more than twice during the 2007 irrigation season, the credit paid to the participant by the Company will be reduced by the replacement cost of the energy during the dispatch event.

YOU ARE FURTHER NOTIFIED that the Commission has determined that the public interest may not require a formal hearing in this matter and will proceed under Modified
