Idaho Power Company ("Idaho Power" or "Company") hereby respectfully submits to the Idaho Public Utilities Commission ("Commission"), in compliance with Order No. 33313, final documents pertaining to the exchange of certain transmission assets with PacifiCorp d/b/a Rocky Mountain Power and Pacific Power (collectively referred to as "PacifiCorp"). In addition, the Company seeks Commission verification that its regulatory accounting meets the requirements of the Commission's June 5, 2015, Order No. 33313.
