COMES NOW the above-entitled Appellant Avimor, LLC, ("Avimor") by and through its attorneys of record, Fisher Pusch & Alderman, and moves the Idaho Supreme Court to stay this appeal pursuant to Idaho Appellate Rule 13.2 for the reasons herein stated.


