It seems in the not too distant past we paid \$3.28/mo for Basic Monthly Charge on our bills & then it went to \$4.00 & now they want to take it to \$6.75 - More than Double the \$3.28 we used to pay - For those of us with smaller gas usage I paid \$1.14 for gas + \$4.00 last month) & then Kootenai Electric for electrical use to PAY (along with their 65% increase in 'availability fee' last Fall) it seems excessive - why don't they just charge us for what we use and increase that rate if they need to - I don't mind paying for what I use but these constant upward excessive Monthly fees are abusive.
