Dear Ms. Walters:

On March 27, 2002, Adelphia Business Solutions Operations, Inc. ("ABSO") filed for protection under Chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York. The filing was designed to afford us an opportunity to work on restructuring our debt while continuing to operate the business in the normal course and continue to provide our customers with the same quality service and availability of our products. In order to preserve and strengthen our business and to be able to successfully reorganize, we have found it necessary to re-evaluate our business plan, including states where we currently provide service and those states where we had obtained certification and intended to initiate service. During this evaluation, we have determined, to be able to successfully reorganize, we would need to reduce certain services that we currently provide and to abandon certifications in those states where we will be unable to expand due to our revised business plan.

Idaho is one of the states where ABSO obtained certification, but is not currently providing service. Accordingly, we hereby respectfully request that the following certificate be cancelled:

Certificate of Authority to Conduct Business As a Local Exchange Carrier
in Nonrural Areas Within the State of Idaho – Dated January 5, 2000,
Case No. GNR-T-99-19, Certificate No. 369.

Also enclosed is a proof of filing copy of this letter, which we ask that you date-stamp and return in the enclosed self-addressed, postage pre-paid envelope.


