On November 10, 2016, Boomerang Wireless, LLC dba enTouch Wireless moved the Idaho Public Utilities Commission (Commission), under Commission Rules of Procedure 19 and 43.03 and Idaho Bar Commission Rule (IBCR) 227, for an Order approving the limited admission, pro hac vice, of Thorvald A. Nelson in this matter. The Motion was signed and attested to by local counsel Brian T. Hansen of Boise, Idaho (Idaho State Bar License No. 6087).

In the Motion, Mr. Nelson certifies that he is an active member in good standing of the Colorado and Montana State Bars who maintains the regular practice of law in Colorado. He further declares that he is not an Idaho resident or licensed to practice law in Idaho.

Mr. Nelson and Mr. Hansen certify that a copy of the Motion has been served on all other parties to this case, and that a copy of the Motion, accompanied by a \$325 fee and certificate of good standing, have been submitted to the Idaho State Bar. Mr. Hansen acknowledges that his attendance shall be required at all Commission proceedings in which Mr. Nelson appears, unless specifically excused by the Commission.

COMMISSION FINDINGS

The Commission has reviewed and considered the Motion and applicable rules, including IBCR 227 and Commission Rules of Procedure 19 and 43.03, IDAPA 31.01.01.019 and 043.03. Based on the filings of record and certified representations of Mr. Nelson and Mr. Hansen, we find that reasonable grounds have been demonstrated to justify the granting of limited admission of Mr. Nelson as legal counsel for enTouch Wireless. We further find good reason to excuse the appearance of Mr. Hansen in further proceedings in this docket unless needed by Mr. Nelson.

CONCLUSIONS OF LAW




