("Contact" or "Company") filed an Application for a Certificate of Public Convenience and Necessity (CPCN) to provide advanced data services to Internet Service Providers (ISPs) and other retailers on a wholesale basis, operating as both a reseller and facility-based provider throughout Idaho. Contact will also provide Voice over Internet Protocol (VoIP) services on a retail basis to business and residential consumers.

YOU ARE FURTHER NOTIFIED that Contact is a Wyoming corporation with its corporate headquarters in Riverton, Wyoming. Contact is authorized by the Idaho Secretary of State to transact business within the State of Idaho and has a registered agent for service in Idaho.

**NOTICE OF MODIFIED PROCEDURE**

YOU ARE FURTHER NOTIFIED that the Commission has reviewed the Application in this case and has preliminarily determined that the public interest in this matter may not require a hearing to consider the issues presented, and that the issues raised by the Application may be processed under **Modified Procedure**, i.e., by written submission rather than by hearing. YOU ARE FURTHER NOTIFIED that the Commission may not hold a hearing in this proceeding unless it receives written protests or comments opposing the use of Modified Procedure and stating why Modified Procedure should not be used. IDAPA 31.01.01.203.


## ORDER


