Direct Communications Star West, Inc. (DCSW) filed with the Idaho Public Utilities Commission (IPUC) for a Certificate of Public Convenience and Necessity (CPCN) in 2005 and was issued a CPCN in Idaho Public Utility Commission (IPUC) Order No. 30116 on August 21, 2006.

The assets that were in DCSW which were used to provide broadband and dial-up Internet access have been moved to Direct Communications Cable LLC (DCC) which provides all of the non-regulated telecommunications services for Direct Communications and its affiliated companies. We would like to request the CPCN that is held in DCSW be transferred to Direct Communications Cable LLC. Attached is a Certificate of Existence from the Secretary of State of Idaho for DCC.

Direct Communications Star West, Inc. will no longer provide non-regulated telecommunications services but will now be providing management services to the Direct Communication family of companies.
