On November 18, 2011 the Federal Communications Commission ("FCC") released its *USF/ICC Transformation Order* in WC Docket No. 10-90 et al. With that Order, the FCC began a transition to a national framework for certification of Eligible Telecommunications Carriers ("ETCs") and set forth a standard set of information that all ETCs must file by April 1 of each year. The Order also required ETCs to provide the same information to the respective state commissions. In subsequent orders, issued on February 3, and May 14, 2012, the FCC modified certain of the reporting requirements to comply with the federal Paperwork Reduction Act and revised its rules to moved the annual filing date to July 1 of each year

For 2012, ETCs must file information that fulfills 47 C.F.R. 54.313(a)(2) through (a)(6) to the extent the information has been collected pursuant to state ETC certification requirements and 47 C.F.R. 54.313(h) by July 2, 2012. **CenturyTel of Idaho d/b/a CenturyLink** hereby provides the information that fulfills 47 C.F.R. 54.313(h) to the Idaho Public Utilities Commission as required by the *USF/ICC Transformation Order*. In addition, CenturyLink is providing the information that fulfills 47 C.F.R. 54.313(8). On April 2, 2012, CenturyLink filed the information responsive to 47 C.F.R. 54.313(a)(2) through (a)(6) with the Commission and will not be updating that information as a result of the July 2, 2012 FCC filing.

Any additional state-specific ETC certification requirements will be provided pursuant to Idaho obligations and on current filing schedules. Consistent with past years, you will need to certify to the FCC pursuant to 47 C.F.R 54.314 in order for CenturyLink to continue receiving Federal high cost support in Idaho.

**Response:**

In the Federal Communications Commission (FCC) Third Order On Reconsideration in the matter of Connect America Fund, *et al.*, FCC 12-52 §19 and §21, the FCC has determined that all incumbent local exchange carrier recipients of high-cost loop or high-cost model support must report residential local rates to the extent that the sum of that rate, and specific state regulated fees is below the effective rate floor, rather than requiring the reporting of all rates. Carriers shall now report lines and rates in effect as of June 1, 2012.


