C.F.R. § 54.313(a) ("Certification, States that desire eligible telecommunications carriers to receive support pursuant to the high-cost program must file an annual certifications with the Administrator and the Commission stating that all federal high-cost support provide to such carriers within that Stat was used in the preceding calendar year and will be used in the coming calendar year only for the provision, maintenance, and upgrading of facilities and services for which the support is intended. High-cost support shall only be provided to the extent that the State has filed the requisite certification pursuant to this section.")
