On behalf of those Idaho local exchange carriers listed below, and pursuant to 47 C.F.R. 54.304(d)(1) of the Federal Communications Commission regulations, we are filing projected eligibility for CAF ICC funding for July 1, 2016 through June 30, 2017, and Local Rate Floor Data. In addition to the redacted hard copies for each company, this information is also being submitted on the enclosed CD-ROM.
