Dear Ms. Jewell,

Please accept this letter as IntelPeer, Inc.'s request to change its corporate name to Airus, Inc. IntelPeer, Inc. is authorized to provide local exchange telecommunications services and intrastate interexchange services pursuant to authority granted by the Commission in Docket No. IPI-T-09-01, Order No. 31704. This name change is not an element of a larger transaction. No changes have been made to the Company's corporate organization or ownership. Moreover, the change of the Company's name does not affect the rates, terms and conditions under which IntelPeer's customers would receive service. Importantly, IntelPeer currently does not have end user communications customers in the State of Idaho. The Company requests that its authorization in Idaho be reissued or otherwise revised to reflect its new name.

Airus is a Delaware corporation, registered with the Idaho Secretary of State to transact business as a foreign corporation. A copy of the Company's amended formation documents is appended as Attachment 1. A copy of the Company's amended foreign corporate qualification document is also provided in Attachment 1.

Revised copies of the Company's approved tariffs in Idaho are appended as Attachment 2. The tariff material mirrors what is currently on file with the Commission.

DOES HEREBY CERTIFY:

FIRST: The name of the Corporation is IntelePeer, Inc. and that this Corporation was originally incorporated pursuant to the DGCL on October 5, 2006 under the name Voex, Inc. An Amended and Restated Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on January 31, 2012. A Certificate of Merger was filed with the Secretary of State of Delaware on July 23, 2012 which amended the Amended and Restated Certificate of Incorporation of the Corporation.

SECOND: That the Board of Directors duly adopted resolutions proposing to amend the Amended and Restated Certificate of Incorporation, declaring said amendment to be advisable and in the best interests of this Corporation and its stockholders, and authorizing the appropriate officers of this Corporation to solicit the consent of the stockholders therefor, which resolution setting forth the proposed amendment is as follows:

RESOLVED, that Article I of the Amended and Restated Certificate of Incorporation of this Corporation be amended and restated in its entirety as follows:

"ARTICLE I

"The name of this Corporation is Airus, Inc. (the "*Corporation*")."

THIRD: The foregoing amendment was approved by the holders of the requisite number of shares of said Corporation in accordance with Sections 228 and 242 of the DGCL.

FOURTH: The foregoing amendment has been duly adopted in accordance with Section 242 of the DGCL.

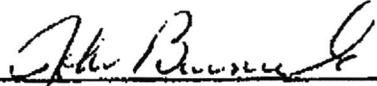
