AFS is authorized to provide facilities-based and resold local exchange and emerging telecommunications services pursuant to Certificate No. 427 issued in Order No. 29494, IZ2-T-04-1 issued on May 11, 2004 as amended on November 26, 2007 (the "Certificate"). AFS, however, does not provide any local exchange services and does not intend to do so in the future.

Because AFS does not serve any local exchange customers in Idaho, AFS respectfully submits that the withdrawal of its Certificate and any effective tariffs is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.
