On December 29, 2010, the Commission issued Order No. 32153 granting Liberty-Bell Telecom, LLC a Certificate of Public Convenience and Necessity to provide facilities-based local exchange, switched exchange access and non-facilities-based interexchange telecommunications services in Idaho. In January 2011, Certificate No. 500 was issued to Liberty-Bell.

On March 23, 2011, Liberty-Bell notified the Commission that it had changed the name under which it does business from Liberty-Bell Telecom, LLC to Liberty-Bell, LLC dba DISH Network Phone & Internet. The name change results from acquisition of a controlling interest of Liberty-Bell, LLC, by DISH Media Holdings Corporation, a wholly owned subsidiary of DISH Network Corporation. Liberty-Bell provided an updated price list reflecting the new business name, an Idaho Certificate of Assumed Business Name from the Idaho Secretary of State's office. The Company states that it does not currently serve any customers in Idaho; accordingly no separate customer notice is required.

Based on our review of the Application, we find that it is reasonable to amend Certificate of Public Convenience and Necessity No. 500 to reflect the change from Liberty-Bell, LLC to Liberty-Bell, LLC dba DISH Network Phone & Internet.

**ORDER**

IT IS HEREBY ORDERED that Certificate of Public Convenience and Necessity No. 500 is amended to reflect the name change from Liberty-Bell Telecom, LLC to Liberty-Bell, LLC dba DISH Network Phone & Internet.

THIS IS A FINAL ORDER. Any person interested in this Order may petition for reconsideration within twenty-one (21) days of the service date of this Order with regard to any matter decided in this Order in Case No. LBT-T-10-01. Within seven (7) days after any person

has petitioned for reconsideration, any other person may cross-petition for reconsideration. See *Idaho Code* §§ 61-626 and 62-619.


