Orbitcom, Inc. (Orbitcom) notified the Commission of the acquisition of OneEighty Networks, Inc. on February 4, 2008. This transaction is now complete.

Orbitcom was granted a CPCN on June 7, 2004 in Docket ORB-T-03-1 Order No. 29516, and subsequently assigned Certificate No. 430. Orbitcom is requesting an update to their CPCN reflecting they will be operating in N. Idaho under their assumed business name of OneEighty Networks. They will continue to operate in S.
