

that “a state commission shall have authority to approve an interconnection agreement adopted by negotiation even if the terms of the agreement do not comply with the requirements of [Part 51].” 47 C.F.R. § 51.3.

THE CURRENT APPLICATIONS

The Commission has been asked to approve two new interconnection agreements and two amendments to existing interconnection agreements. The new agreements and amendments are discussed in greater detail below.

1. Qwest and Z-Tel Communications Inc. (Case No. QWE-T-01-12). This Application is for an amendment to an existing interconnection agreement adding terms for line splitting in accordance with the FCC’s Triennial Review Order.

2. Qwest and NOS Communications, Inc. (Case No. QWE-T-01-19). This Application is for an amendment to update the rates in Appendix A to include recent changes in Qwest’s SGAT rates.

3. Qwest and Lightyear Communications, Inc. (Case No. QWE-T-03-11). This Application is for an amendment to update the rates in Appendix A to include recent changes in Qwest’s SGAT rates.

4. Qwest and All Idaho LLC (Case No. QWE-T-04-02). This Application is for a new SGAT agreement.

STAFF RECOMMENDATION

The Staff has reviewed these Applications and did not find any terms and conditions to be discriminatory or contrary to the public interest. Staff believes that the new agreement and amendments to interconnection agreements are consistent with the pro-competitive policies of this Commission, the Idaho Legislature, and the federal Telecommunications Act. Accordingly, Staff believes that the Applications merit the Commission’s approval.

COMMISSION DECISION

Under the terms of the Telecommunications Act, interconnection agreements must be submitted to the Commission for approval. 47 U.S.C. § 252 (e)(1). The Commission’s review is limited, however. The Commission may reject an agreement adopted by negotiation only if it finds that the agreement discriminates against a telecommunication carrier not a party to the agreement or implementation of the agreement is not consistent with the public interest, convenience and necessity. *Id.* Based upon our review of the Applications, the Staff’s

recommendation and on the fact no other person commented on these Applications, the Commission finds that the new agreement and amendments to previously approved interconnection agreements are consistent with the public interest, convenience and necessity and do not discriminate. Therefore, the Commission finds that these Applications should be approved. However, approval of these new agreements and amendments to previously approved agreements does not negate the responsibility of any of the parties to these agreements to obtain a Certificate of Public Convenience and Necessity if they are offering local exchange services or complying with *Idaho Code* §§ 62-604 and 62-606 if they are providing other non-basic local telecommunications services as defined by *Idaho Code* § 62-603.

ORDER

IT IS HEREBY ORDERED that the new interconnection agreement and amendments to interconnection agreements discussed above are approved. Terms of the agreements that are not already in effect shall be effective as of the date of this Order.

IT IS FURTHER ORDERED that the amendment to an interconnection agreement between Qwest Corporation and Z-Tel Communications, Inc., Case No. QWE-T-01-12, is approved.


IT IS FURTHER ORDERED that the amendment to an interconnection agreement between Qwest Corporation and NOS Communications, Inc., Case No. QWE-T-01-19, is approved.

IT IS FURTHER ORDERED that the amendment to an interconnection agreement between Qwest Corporation and Lightyear Communications, Inc., Case No. QWE-T-03-11, is approved.

IT IS FURTHER ORDERED that the interconnection agreement between Qwest Corporation and All Idaho LLC, Case No. QWE-T-04-2, is approved.

THIS IS A FINAL ORDER. Any person interested in this Order (or in issues finally decided by this Order) or in interlocutory Orders previously issued in these Case Nos. QWE-T-01-12, QWE-T-01-19, QWE-T-03-11 and QWE-T-04-2, may petition for reconsideration within twenty-one (21) days of the service date of this Order with regard to any matter decided in this Order or in interlocutory Orders previously issued in these cases. Within seven (7) days after any person has petitioned for reconsideration, any other person may cross-petition for reconsideration. *See Idaho Code* §§ 61-626 and 62-619.


