**RE:** QWEST CORPORATION'S APPLICATION FOR APPROVAL OF THE  
INTERCONNECTION AGREEMENT WITH BROADVOX-CLEC, LCC;  
CASE NO. QWE-T-11-06.

### BACKGROUND

Under the provisions of the federal Telecommunications Act of 1996, interconnection agreements must be submitted to the Commission for approval. 47 U.S.C. § 252(e)(1). The Commission may reject an agreement adopted by negotiations only if it finds that the agreement: (1) discriminates against a telecommunications carrier not a party to the agreement; or (2) implementation of the agreement is not consistent with the public interest, convenience and necessity. 47 U.S.C. § 252(e)(2)(A).

### CURRENT APPLICATION

On May 20, 2011, Qwest Corporation (Qwest) submitted an Application for approval of an interconnection agreement with Broadvox-CLEC, LLC. In this Application, the parties request Commission approval to adopt in its entirety, the terms and conditions of Neutral Tandem, Inc's Wireline Interconnection Agreement and any associated amendments, if applicable.

### STAFF ANALYSIS

Staff has reviewed the Application and does not find that any terms or conditions are discriminatory or contrary to the public interest. Staff believes the Application is consistent with the FCC orders and pro-competitive policies of this Commission, the Idaho Legislature, and the

federal Telecommunications Act. Accordingly, Staff recommends Commission approval of the Application for Approval of Amendment to the Interconnection Agreement.
