IT IS HEREBY CERTIFIED that this Certificate of Public Convenience and Necessity, Certificate No. 329, is issued to Columbine Telephone Company, Inc. This Certificate authorizes Columbine to provide Title 61 regulated telecommunications services, including basic exchange services, within parts of the State of Idaho. The Commission approved Columbine's Certificate by Order No. 27166 issued October 20, 1997. Columbine is authorized to provide Title 61 services in the following territory:




