**NOTICE OF APPLICATION**

YOU ARE HEREBY NOTIFIED that on March 15, 2005, Tamarack Video & Telecom LLC ("Tamarack" or "Company") filed an Application for a Certificate of Public Convenience and Necessity to provide local exchange and toll services within the State of Idaho. Tamarack filed an Amended Application for Certification on April 15, 2005.

YOU ARE FURTHER NOTIFIED that Tamarack intends to provide local exchange and interexchange services primarily to residential and business customers at the Tamarack Resort in Valley County, Idaho. Initially, Tamarack will provide local exchange service, Voice over Internet Protocol, and other services. In addition, Tamarack plans to offer interexchange telecommunications services on a resale basis. Tamarack will compete primarily with the incumbent local exchange carrier, Frontier.

YOU ARE FURTHER NOTIFIED that Tamarack is an Idaho limited liability company with a corporate office and registered agent located in Boise, Idaho. Tamarack is wholly owned by Tamarack Resort, LLC.

**NOTICE OF MODIFIED PROCEDURE**

YOU ARE FURTHER NOTIFIED that the Commission has reviewed the Application in this case and has preliminarily determined that the public interest in this matter may not require a hearing to consider the issues presented, and that the issues raised by the Application may be processed under **Modified Procedure**, i.e., by written submission rather than by hearing. The comment must contain a statement of reasons supporting the comment. Persons desiring a hearing must specifically request a hearing in their written comments. YOU ARE FURTHER NOTIFIED that the Application together with supporting workpapers and exhibits have been filed with the Commission and are available for public




