COMES NOW Time Warner Cable Information Services (Idaho), LLC, d/b/a Time Warner Cable ("Applicant"), by and through its attorneys, and hereby submits this application for registration/certification as a wholesale telecommunications services provider within the State of Idaho. Applicant respectfully requests that the Idaho Public Utilities Commission ("Commission") grant this Registration/Certification pursuant to Commission Order No. 32277, in Case No. GNR-T-11-01, Commission Rule of Procedure 114 and Title 62 of the *Idaho Code*.

1. Name, Address and Form of Business.

A. Applicant is a competitive telecommunications company that intends to offer intrastate telecommunications services for commercial and wholesale customers statewide. Such services may include point to point, private line, access and transport services.

B. Applicant is a Delaware limited liability company.
