

PETITION TO INTERVENE

COMES NOW Allied Wireless Communications Corporation (“Allied Wireless”) and, pursuant to RP 71—75, Petitions to Intervene in the above matter and in support thereof respectfully shows as follows, to wit:

I.

Allied Wireless is a commercial mobile radio services (“CMRS”) carrier licensed by the Federal Communications Commission (“FCC”) to provide service in various locations in Idaho. Allied Wireless is a wholly owned subsidiary of Atlantic Tele-

Network, Inc., ("ATNI") a publicly-traded corporation headquartered in Beverly, Massachusetts. Previously, ATNI, and ultimately Allied Wireless acquired certain wireless assets, licenses and accompanying authorizations in six states, including Idaho, from subsidiaries of Verizon Wireless. Allied Wireless is designated as an Eligible Telecommunications Carrier in Idaho. (Order No. 32209).

On June 2, 2011, Allied Wireless filed Comments, Protest to Use of Modified Procedure and Request for Hearing in the above-captioned docket jointly with the Idaho Telecom Alliance, CTC Telecom, Inc., Syringa Wireless, LLC and Rural Telephone Company. As indicated therein, the Application of T-Mobile presents a number of issues warranting further investigation, including, among others,

- The potential impact of AT&T's acquisition of T-Mobile on T-Mobile's use of Federal Universal Service Funds;
- The depth of T-Mobile's commitment to expand its service into rural areas of Idaho;
- The impact on funding for other Eligible Telecommunications Carriers under the Interim Cap recently imposed by the Federal Communications Commission.

IV.

Based on the foregoing, Allied Wireless has a direct and substantial interest in this proceeding, which interest is not adequately represented by other parties.


V.
