On July 27, 2007, Falls Water Company filed a general rate case Application seeking authority to increase its metered rates an average of 46.2%. Falls Water serves approximately 3,200 customers near Ammon and Idaho Falls. Because the Company is in the process of installing meters for its current flat-rate customers, the Company is not requesting any increase in its flat-rate service under Schedule R-2. The Company anticipates that it will have converted all of its existing flat-rate customers to metered service by mid-2008.

In Order No. 30404, the Commission issued a Notice of Application and suspended the proposed rates for a period of 30 days plus 5 months. The Commission also set a deadline for intervention of August 28, 2007. No person petitioned for intervention. On September 4, 2007, the Commission Secretary issued the Notice of Parties consisting of the Company and the Commission Staff.

Pursuant to the Commission's direction, the Staff and the Company reached agreement on how the case should be processed and on a proposed schedule. The parties recommend that the rate case be processed under Modified Procedure with the Commission holding a public hearing in Idaho Falls. The parties proposed and we adopt the following schedule.
