I appreciate your questions relative to the Idaho Public Utilities Commission Case No. GNR-W-04-01 and will seek to address the questions raised in your January 27, 2007, letter.

1. Regarding whether or not Eagle Water Company's service area ends west of Old Horseshoe Bend Road, I recommend that you contact Eagle Water to verify its service area boundaries.
2. No, you would not be required to connect to United Water's system. At the present time, United Water does not have water mains in this area. If in the future the company extends mains to this area, you still would not be required to connect unless you so chose.
3. Since there are no mains in this area and service would require a main extension, it is not possible at this time to determine the cost for you to connect to United Water's system.
4. Yes, you would retain the water rights to your personal well. This stipulation agreement designates service territory boundaries for the two companies. It does not affect individual water rights.
