On August 31, 2006, the Commission granted Kootenai Heights Water System's request for a Certificate of Public Convenience and Necessity authorizing it to operate as a public utility in the State of Idaho. Order No. 30122. In response to the Company's objection to the Commission's jurisdiction, the Commission granted reconsideration of its Order as to the sole issue of whether Kootenai Heights Water was a public utility as defined by Idaho Code and thus subject to the jurisdiction of the Commission. Order No. 30138. On January 10, 2007, the Commission affirmed Order No. 30122 finding that Kootenai Heights Water is a public utility as defined by Idaho law and subject to the jurisdiction of the Commission. Order No. 30219.

Order No. 30219 directs that the parties shall meet and conduct an informal prehearing conference where they shall discuss the remaining issues relating to rates, charges, rules, and regulations exploring any possibilities for agreement. *Id.* at 10. Additionally, the Commission directed that if the parties cannot resolve the remaining issues, then they shall submit a proposed schedule for the submission of prefiled direct testimony, rebuttal, and an evidentiary hearing pursuant to the Commission's Rules of Procedure. *Id.*
