
COMES NOW, Mayfield Springs Water Company, Inc., (the "Company") by and through its counsel, Fisher Pusch & Alderman LLP and files its Response to Commission Order No. 30628 as required concerning the ownership of certain water rights. On February 1, 2008 Arbor Ridge, LLC sold the assets of the water company, including water rights (Water Right No. 63-12260 and Water Right Nos. 63-31745 & 63-31881), to Idaho Springs Water Company which later changed its name to Mayfield Springs Water Company. *See Exhibit 38.* Counsel has been advised by the Company's engineers, SPF Engineering, Inc., that they are drafting a "Notice of Change of Ownership" (the "Notice") to be filed on behalf of the Company with the Idaho Department of Water Resources ("IDWR") which provides notice that the water rights identified above are now owned by Mayfield Springs Water Company. As soon as the Notice is submitted to IDWR a copy will also be filed with the Commission.


