On July 28, 2017, Rickel Water and Bitterroot Water jointly applied to the Commission to consolidate the two companies into one. Staff has reviewed the Companies' application, requested information from the owner of the Companies, and pursuant to Commission direction, convened with the Companies, and requested the Commission set a scheduling order.
