On January 31, 2007, United Water Idaho Inc. (United Water; Company) filed an Application with the Idaho Public Utilities Commission (Commission) requesting authority to amend and revise its Certificate of Public Convenience and Necessity No. 143, as amended, to include an area in Ada County, Idaho identified as Lanewood Estates. *Idaho Code* § 61-526; IDAPA 31.01.01.112. The proposed Lanewood Estates development lies adjacent to the City of Eagle, north of Floating Feather Road, south of Beacon Light and west of north Linder Road in Ada County. The Application of the Company includes a legal description and map of the Lanewood Estates area.

Pursuant to Commission Notice, a Prehearing Conference in Case No. UWI-W-07-02 was held in Boise, Idaho on March 22, 2007. Pursuant to agreement of the parties and the Commission YOU ARE HEREBY NOTIFIED that the following scheduling in Case No. UWI-W-07-02 has been adopted:

YOU ARE FURTHER NOTIFIED that all proceedings in this case will be held pursuant to the Commission's jurisdiction under Title 61 of the Idaho Code and that the Commission may enter any final Order consistent with its authority under Title 61.


